

Green Plank Wood-Composite Limited Warranty

Green Plank AB (hereinafter "GREENPLANK") warrants to the original end user purchaser ("Purchaser") that, on a prorated basis, for a period of fifteen (15) years from the date of original purchase, GREENPLANK products shall be free from defects in material and manufacture when used for its intended purpose and properly installed and maintained according to GREENPLANK's published installation instructions to (a) resist rot or fungal decay and (b) resist damage caused by insect or termite attacks. If a defect occurs within the warranty period, the Purchaser shall notify GREENPLANK in writing and, upon confirmation by an authorized GREENPLANK representative of the defect, GREENPLANK's sole responsibility shall be, at its option, to either replace the defective item or refund the portion of the purchase price paid by the Purchaser for such defective item (not including the cost of its initial installation).

This warranty shall not cover and GREENPLANK shall not be responsible for costs and expenses incurred with respect to the removal of defective GREENPLANK products, any freight, labor or the installation of replacement materials.

To make a claim under this limited warranty, Purchaser shall send to GREENPLANK, within 30 days from when the Purchaser became aware of the defect, a description of the claimed defect with pictures and proof of purchase, at the following address:

GREENPLANK does not warrant against and is not responsible for, and no implied warranty shall be deemed to cover, any condition attributable to: (1) improper installation of GREENPLANK's products and/or failure to abide by GREENPLANK's installation guidelines, including but not limited to improper gapping; (2) use of GREENPLANK products beyond normal commercial and residential use, or in an application not recommended by GREENPLANK's guidelines and local building codes; (3) movement, distortion, collapse or settling of the ground or the supporting structure on which GREENPLANK's products are installed; (4) any act of God (such as flooding, hurricane, earthquake, lightning, etc.), environmental condition (such as air pollution, mold, mildew, etc.), staining from substances (such as dirt, grease, oil, etc.), or normal weathering (defined as exposure to sunlight, weather and atmosphere which will cause any colored surface to gradually fade, chalk, or accumulate dirt or stains); (5) variations or changes in color of GREENPLANK products; (6) improper handling, storage, abuse or neglect of GREENPLANK products by Purchaser, or third parties; or (7) ordinary wear and tear.

GREENPLANK shall not be liable for incidental, special, consequential or other similar damages arising from the breach of this warranty. In particular, the liability of GREENPLANK, if any, and the Purchaser's sole remedy for damages for any claim of any kind whatsoever, regardless of legal theory and whether arising in tort or contract, shall not be greater than the actual purchase price of the product with respect to which such claim was made.

No person or entity is authorized by GREENPLANK to make and GREENPLANK shall not be bound by any statement or representation as to the quality or performance of GREENPLANK products other than as contained in this warranty. This warranty may not be altered or amended except in a written instrument signed by GREENPLANK and Purchaser.

UNDER NO CIRCUMSTANCES WILL GREENPLANK BE LIABLE FOR SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES, WHETHER SUCH DAMAGES ARE SOUGHT IN CONTRACT, IN TORT (INCLUDING BUT NOT LIMITED TO NEGLIGENCE AND STRICT LIABILITY) OR OTHERWISE, AND GREENPLANK'S LIABILITY WITH RESPECT TO DEFECTIVE PRODUCTS SHALL IN NO EVENT EXCEED THE REPLACEMENT OF SUCH PRODUCTS OR REFUND OF THE PURCHASE PRICE, AS DESCRIBED ABOVE.
